**CONSIDERING THAT:**

**GUS Italia** manages the project “Back to the Future” funded in the framework of the Asylum, Migration and Integration Fund (AMIF), Specific objective Return – National objective 2 Return measures, PROG 237 which started in August 2016 and will end in March 2018 with a potential extension to 30 June 2018;

In the framework of AMIF, Return aims at enhancing fair and effective return strategies, which contribute to combating irregular migration, with an emphasis on sustainability and effectiveness of the return process;

“Back to the Future” is a project of Assisted Voluntary Return and Reintegration (AVRR) that offers assistance to Third Country Nationals (TCNs) including Bangladeshi citizens who are in Italy, to return to their countries of origin on a voluntary basis;

“Back to the Future” is receiving several applications from Bangladeshi citizens who intend to voluntarily return to Bangladesh;

**Global Development Consultants** is an associate partner of the project “Back to the Future” and subsequently committed to support and facilitate GUS in the implementation of project’s activities in Bangladesh.

**UNDERTAKE TO:**

**As refer to GUS Italia:**

Refer to **GDC** as local partner for the AVRR applications submitted by Bangladeshi citizens;

Outline the Plans of Reintegration (PoR) on behalf of Bangladeshi citizens’ beneficiaries of the project and share them with **GDC** for feedback;

Following signature of the contract for each beneficiary, transfer to **GDC** a budget of 2,000 euros (Two Thousand) per person/beneficiary for the implementation of his/her Plans of Reintegration (PoR);

Upon their arrival in Bangladesh, manage the above-mentioned budget, for the procurement of relevant goods and services according to PoR. Any amendments of PoRs are possible upon agreement with the beneficiary and **GUS Italia**;

Carry out the reporting activity according to the project’s monitoring procedures, by submitting one interim report following each beneficiary’s arrival in Bangladesh; and one final report at the end of the monitoring period;

Following receipt of invoices documenting the purchases of goods and services carried out for the implementation of PoR, **GDC** will receive 200 euros per beneficiary as its service fees. In addition to 200 Euro fees per beneficiaries, for those returning outside Dhaka city limits, **GUS - Italia** will pay to **GDC** 400 euros for each beneficiary monitored (i.e. a total of 600 Euro);

**As refer to Global Development Consultants:**

Provide feedback on the feasibility of the PoR on behalf of Bangladeshi citizens returning to Bangladesh, outlined by **GUS Italia**;

Provide to each beneficiary of the project with an accurate reintegration assistance and monitoring (e.g. search for job opportunities, vocational training, education, medical assistance, housing) according to each individual PoR;

Meet the beneficiaries of the project upon arrival in Bangladesh, sign the “Declaration of Arrival” provided by **GUS Italia**, between **GDC** Representative and project’s beneficiary;
